- 5.1 You are appointed as History teacher at one of Musina secondary schools and given Apartheid topic to teach. Write notes explaining what Apartheid was.
  - ➤ Apartheid was a policy or system that separated or segregated group of people based on their race, with Whites superior to other races. Apartheid ideology used skin colour and other physical characteristics of South Africans to classify people into races groups.
  - ➤ Apartheid system sought to oppress blacks and as result the United Nations viewed it as crime against as many people was massacred, while protesting against all forms of racists.
  - ➤ Racists divided the human race into different racial groups and believe that it is acceptable to exclude or dominate certain of these groups on the grounds of their race. Black South Africans were referred to as non-whites. Non-whites were divided into categories called 'Native or Bantu' Coloured and Indian people.
  - ➤ The Afrikaans word 'Apartheid' means Apartness, in which was inhumane policy which kept Whites separate from black South Africans. Apartheid ideology said that light skinned people (whites) were superior to dark-skinned people (blacks). This ideology was used to justify the oppression of black South Africans.
  - ➤ During the Apartheid regime blacks were not treated the same as white, blacks were not allowed to marry White people. Whites and Blacks were forced to go to different schools
  - > Blacks could not up business in White areas and were not allowed to live in the urban areas
